water DISTRICT #2 — Resident, Michael Knuetter, has taken to social media to express his concern regarding a broken water line at his residence.

Jim Winn and Paul Baker have determined that the break is on the property owners' side of the line. It has always been the town's policy that if the break was on the property owners' side of the line, the town would not be responsible for correcting those issues. In an effort to minimize damage to the rest of the town's water supply, and the newly constructed system, the water to this residence has been shut off. Supervisor Jaeger then contacted the county health department. The county determined the town is well withing their rights to turn off the water and it is the homeowner's responsibility to have the line repaired. Supervisor Jaeger has informed Mr. Knuetter of the town's longstanding policy in writing. Mr. Knuetter was advised the town is not responsible for repairs made to private property owner's lines, and that he will need to have his water line repaired by a certified/licensed contractor before the water can be turned back on to his residence.

Supervisor Jaeger reaffirmed the Town's longstanding policy that the Town of Berlin is not responsible for repairs made to a resident's private line. It is the property owner's responsibility to have issues concerning the private water line corrected within seven (7) calendar days by a licensed/certified contractor. Councilman Douglas Feathers seconded the motion.

The Engineer would like to schedule an internal inspection of the property at 111 Green Hollow Rd before making a final determination. Once a determination has been made the letters will be mailed to the property owners.
