

REGULAR TOWN BOARD MEETING

Town of Berlin
December 11, 2025
7:30p.m.

The Town Board of the Town of Berlin, County of Rensselaer, State of New York met on the above date to transact such business as may lawfully come before such board. Members present were Supervisor Robert Jaeger, Councilman Stephen Riccardi, Councilman John Winn, and Councilman Dean Maxon. Councilman Douglas Feathers was absent.

CODE ENFORCEMENT OFFICER – CEO Walter Yerdon reported that there are a lot of solar permits being issued. The new energy requirements that had been purposed by the state have been postponed.

TRANSFER STATION – Transfer station supervisor Doug Goodermote reported that there needs to be a change on how we accept fluorescent lightbulbs. The town of Berlin is the only transfer station in the area that accepts them, and they are being overrun by them.

AMBULANCE – Supervisor Jaeger reported that the building has been erected and electrical service is being installed. The board was given an ambulance service agreement between the Town of Berlin and Taconic Valley Ambulance, Inc.
